DR. ISMAEL CABRERA GARCIA, Director of GRUPO BARIATRICO DEL NORTE (stop Obesity Bariatric Surgery), declares that he is responsible for the discretion of the personal and sensitive data provided by the Owner, in accordance with the provisions for their treatment in terms of the LFPDPPP by the personnel who work assigned to the responsible party, the workforce being as follows:

The foregoing is not limiting or restrictive to the above, in the sense that various employees may be incorporated into the aforementioned payroll, who will also assume the respective commitments in accordance with the Law on the matter.

Both parties refer to understanding as the LFPDPPP, or Law of the matter, the Federal Law on the Protection of Personal Data in Possession of Private Parties and its regulations.

Description:

This document constitutes the Privacy Notice for the purposes of the provisions of the Federal Law on the Protection of Personal Data in Possession of Private Parties (the "LFPDPPP"), specifically numeral 15 of the aforementioned Law, and the provisions that emanate from it or are related to it. Hospital Centro Medico Premier, Antonio Caso 2055, Zona Urbana Río Tijuana 22010 Tijuana B.C, in its capacity as **Responsible**, under the principles of legality, consent, information, quality, purpose, loyalty, proportionality and responsibility, in accordance with the provisions of the LFPDPPP.



Therefore, we make this **PRIVACY NOTICE** available to clients and/or active patients, new clients and/or patients, to which the employees of **DR. ISMAEL CABRERA GARCIA**, Director of GRUPO BARIATRICO DEL NORTE (**stop Obesity Bariatric Surgery**) are subject, notice by which we describe the personal data to be processed, stored and disclosed, purpose for which they are collected, the options and means that will be used for the exercise of your rights of **Access, Rectification, Cancellation and Opposition that are carried out. In terms of articles 27, 28 and 29 of the LFPDPPP.**

DR. ISMAEL CABRERA GARCIA, Director of GRUPO BARIATRICO DEL NORTE (**stop Obesity Bariatric Surgery**), being in this case the Responsible through himself and/or his Representatives and employees, may, in the exercise of his activities of providing medical services specialized in Bariatric and/or Obesity Surgery, Medical Consultation, and General Surgery and Laparoscopy.

Request, collect, process and disclose the following personal data, in a lawful manner and in accordance with the LFPDPPP, as long as you do not express any objection to the time you provide us with your personal data directly, within the identification file of each patient, such as: name, age, weight, height, body mass index, body fat percentage, body measurements, height, marital status, date of birth, nationality, state of origin, zip code, signature, gender, address, e-mail, landline, work and cell phone number, background and academic preparation, profession, occupation, personal references, family data to notify in case of emergency, name and signature of witness designated by the patient, as well as the following **sensitive** personal data: Racial or ethnic origin, religious, philosophical, and moral beliefs, sexual preferences, body photographs, printed or videotaped images, x-rays, medical and clinical information such as medical history, and medical conditions. The same sensitive data that must be treated in terms of article 13 of the LFPDPPP, which are described below:

Heredo Family Background.

Non-pathological personal history.

Gynecological-obstetric antecedents.

Pathological personal history: surgeries, transfusions, allergies, immunizations, diabetes, hypertension, others, current conditions.

Psychological or Psychiatric History.

Apparatus and systems: Digestive, respiratory, cardiovascular, genitourinary, nervous, musculoskeletal, skin and adnexa, sense organs.

Physical Examination.

By virtue of the fact that we process and store **sensitive personal data**, we require your express consent, in accordance with the provisions of article 3 Section VI and 9 of the LFPDPPP, so we ask you to indicate if you accept this transfer since **DR. ISMAEL CABRERA GARCIA**, Director of GRUPO BARIATRICO DEL NORTE (**stop Obesity Bariatric Surgery**) being in this case the Responsible Party, through itself and/or its Representatives and employees, may transfer to a third party, whether it is a



natural or legal person such as the Companies and private doctors with whom it has commercial and/or professional relations for the purpose of specialized technical medical assistance such as those detailed below:

The foregoing, without being limiting or restrictive, to the aforementioned Hospitals, nor to the patient and/or client going to the Hospital of their choice to perform the medical services that concern us, therefore, if necessary, the doctor may require the specialized technical service of a professional in the field or group of professionals, with the purpose of giving continuity to the medical purposes of merit.

If you do not object to the transfer of your **personal data** for this purpose, it will be understood that you have given your consent to do so.

In relation to the Sensitive Personal Data requested by **DR. ISMAEL CABRERA GARCIA**, Director of GRUPO BARIATRICO DEL NORTE (**stop Obesity Bariatric Surgery**), through him and/or his Representatives and employees, he undertakes that the processing will be absolutely essential for the purposes mentioned in the provision of professional medical services described above, By declaring that it is for internal use, we will not sell, transfer or rent personal information about you to a third party except in the case of your prior objection. The same opposition may be expressed at any time and through the legal means provided for by the LFPDPPP.

Likewise, the responsible party will safeguard all the appropriate security measures to protect the confidentiality of the data provided by the Owner and with regard to the information provided by the Owner regarding other Owners, such as the data of family members; the Owner declares under oath to tell the truth that he/she has the consent of the corresponding Owners and that he/she is authorized by them to provide this information, assuming any liability that may arise by virtue of the LFPDPPP. In terms of articles 3 Section XVIII, 6, 7 and 15 of the LFPDPPP.

MEANS OF REVOKING CONSENT.

At any time, you may request the revocation of the consent granted to **DR. We recommend that you send us your request with the following information:



- Name and address, as well as any additional information that may be used to locate you,
- Document proving identity,
- Concise and clear description describing the rights you wish to exercise, as well as the personal data involved,
- In the case of requesting the rectification of personal data, the documentation supporting the request must be attached.

The response to your request will be sent to you within the deadlines set by the LFPDPPP as long as they are not under the exceptions of article 26 of the same Law and 75 of the regulations, respectively.

At any time, you may revoke the consent you have given us for the processing of your personal data, so that we stop using and transferring them by using the mechanisms provided for this purpose in this document.

We reserve the right to make modifications or updates to this Privacy Notice at any time, in order to respond to legislative reforms, internal policies or new requirements for personal data for the provision or offering of our products or services.

In the event that a security breach occurs at any stage of the processing of personal data that significantly affects your economic or moral rights, the Data Controller will immediately notify you by email of the event of a security breach, so that you can take the necessary measures to defend your rights. If you do not have your email address, the notification will be published at the address of the owner of the data that concerns us.
